### **II. Public Portion**

Martin Drew spoke about the historic landmark legislation. He doesn't believe that something should be called a done deal when it is not. He questioned housing. Where is it? We have been talking about this for a long time. He spoke about other issues of concern to him.

### **III. Topics**

#### **A. Bids - Jeanne Carroza**

Jeanne Carroza spoke about bids for rejection, extension, acceptance, and notice that will be on the agenda for Thursday night's meeting.

Kim Shaw made a recommendation regarding a project on fighting nitrogen uptakes. The proposal is named the Accabonac Micro Algae Biology Extraction Program. The project will be in conjunction with Cornell. Kim went on to describe the project and process itself.

She also spoke about the studies that were done on Pussy's Pond. She will present at the first work session in October.

**B. Dankowski Enhanced Easement - Scott Wilson**

Scott Wilson explained the findings that he out regarding the concerns on the Dankowski property.

Michael Sendlenski spoke about a law suit by Dick Ampers Group regarding agricultural rights on lands where agricultural easements were purchased by Suffolk County. The case is currently being appealed. He spoke about the suit and the Dankowski property.

Scott Wilson spoke about the structures that are already on the property and the use of hoop houses on the property in the future as a result of this law suit.

**C. Historic Landmark Legislation - Michael Sendlenski**

Michael Sendlenski introduced and explained a draft piece of legislation to promote preservation of historic landmarks in the Town of East Hampton that are not already preserved within a historic district. The legislation will be to promote the preservation of special historic landmarks within the town by allowing some of the maximum permitted gross floor area on those properties to be allocated to an accessory dwelling unit on the same lot. Several properties have been identified for possible inclusion in this law. He went on to discuss limitations on the dwellings.

**D. Discuss Resolution to ICLEI - Sylvia Overby**

Sylvia Overby spoke about a blue print that the Energy Sustainability Committee is working on. She spoke about the committee's membership in ICLEI (International Council for Local Environmental Initiatives). By joining we can get technical assistance in gathering and analysing data. The membership costs \$600.00.

**IV. Liaison Reports**

Kathee Burke-Gonzalez spoke about expanding the contract with Vector at the airport. Also to extend the contract with Outside Media. Disability Advisory Committee recommendations were discussed. Curb cuts at the Amagansett Comfort Station and the sidewalk in the area of Windmill Village have been done. Showtime is coming back to East Hampton to film again. They will be meeting with the event committee this Thursday.
